Health Care Coalition Responds to SAMHSA Final Rule on Confidentiality of SUD Patient Records

Washington, DC (July 15, 2020) – The Partnership to Amend 42 CFR Part 2 (Partnership), a coalition of nearly 50 health care organizations committed to aligning 42 CFR Part 2 (Part 2) with the Health Insurance Portability and Accountability Act (HIPAA) for the purposes of treatment, payment, and health care operations (TPO), responds to the adoption of the revised Confidentiality of Substance Use Disorder Patient Records regulation, 42 CFR Part 2, by the Substance Abuse and Mental Health Services Administration (SAMHSA), U.S. Department of Health and Human Services (HHS).

The Partnership commends HHS for its continued attention to patient care for those with substance use disorders (SUDs), and this rule is a step forward. This regulation will allow appropriate access to patient information that is essential for providing safe, effective, whole-person care for people with SUDs. The appropriate sharing of medical and behavioral health records is even more critical in times of public health emergencies like the opioid crisis and the COVID-19 pandemic.

We look forward to future guidance from SAMHSA to fully implement and fulfill the promise of the Protecting Jessica Grubb's Legacy Act, "Legacy Act", that was included in the Coronavirus Aid, Relief, and Economic Security (CARES) Act which was signed into law earlier this year.
